I want you to know that your help means a lot to me and my family and the success of this arrangement will be of great benefit to both families.

However, I want you to know that my family needs your help in making claiming of our family fund in the U.K. which was deposited in a finance company by my late husband. During the current Crisis against the farmers of the Zimbabwe by supporters of our president Robert Mugabe to claim all the white owned farms in our country, the president ordered all the white farmers to surrender their farms to his party members and their followers. It will also protect you from some unscrupulous individual deciding to steal all of your money. You are risking a lot, trying to find someone on the internet to help you and hoping that they just don't take the money and run. I

hope your Financial Advisor didn't tell you to do this. You do realize that if you nominate someone next-of-kin and make them the beneficiary that it is their money to do with as they please and they don't have to share it with you or your son. If the banker advised you to do this, he is a moron. My advice would be to draw up a simple Power of Attorney and Partnership Agreement detailing the conditions you want set forth, that way no one can just run off with your money.
