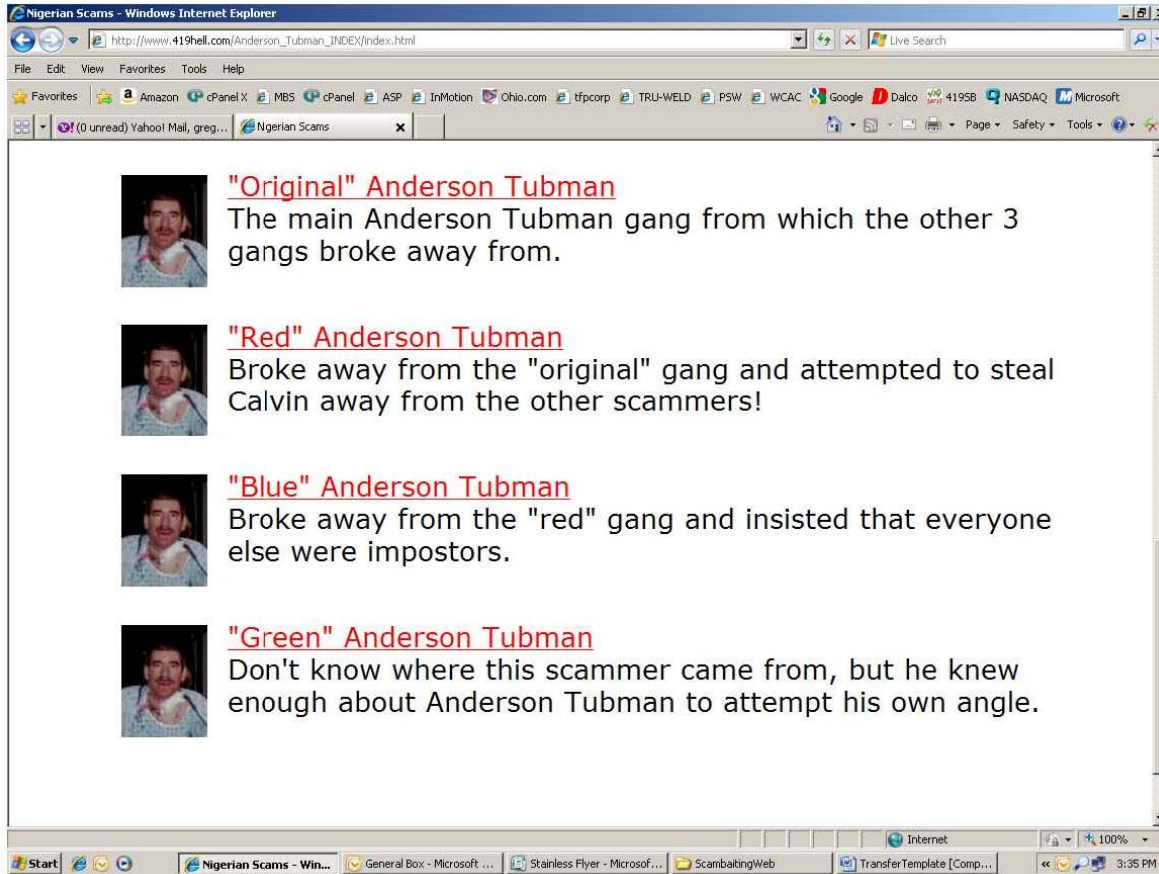
Yeah, I see the difference. But tell me, who is this in this picture?
