Based on the United States legislative and executive decision to withdraw some troops from Afghanistan, I am desperately in need of your assistance and I have summoned up courage to open up to you. I am presently in Afghanistan, and I am seeking your assistance to help me secure the sum of \$12,700,000.00 (Twelve million Seven Hundred Thousand US dollars) to Europe or a safe location, as far as I can be assured that it will be safe until I complete my service here in a couple of weeks. An obvious fake ID. The photo that he used is of General David Petraeus, the Director of the CIA. He Just air brushed some hair and a beard in.





Below is the picture he used and an enlarged photo taken off the scammers ID for comparison... Not a bad identity change, if he had spent a bit more time changing the background a little I wouldn't of found it. I could probably use this later in the game and ask him, "Why if he's a captain called Mike Coutue, is wearing a Generals insignia and his name badge says Petraeus"?



He called himself Luke McConnell in his first e-mail and now he is saying that he's called Mike Couture. A lot of times scammers can't remember which name they have used. I think that I will bring this to his attention and see what he has to say.

Well I underestimated this scammer as his reply surprised me, his answer was semiplausible... that he used a false name to contact me first as he "Didn't know what my reaction would be".

He seems to be a smarter than average scammer as he's thinking on his feet. Not that smart though because he used his "supposedly real" account to send an e-mail using a false name. I will have to tread carefully here all the same.

# 1. Do you require me to come out and retrieve the cash, and if so where will the cash be?

Yes, I require you to retrieve the consignment from the company where it is deposited. I will officially introduce you to the company as the beneficiary to the consignment, once this is done, I will give you the contact of the company so that you can open communication with them directly and arrange whether to meet the in Switzerland to retrieve the consignment or to have them deliver it to you in Manchester. The consignment is deposited with a security vault in Switzerland as Medical materials. I will give you the information of the agent in charge so that you can arrange the rest.

A couple of minutes later he sends me another e-mail. He's tried to phone me and couldn't get through because I gave him a load of fake numbers. He also copied in his last e-mail so I didn't include that.

FORT BELVOIR, Va. August 7, 2012 -- Special agents from the U.S. Army Criminal Investigation Command received a case of Internet scams and of impersonation fraud –

INSCOM has taken up this case to deal with this and other growing issues; the personnel committing these scams are utilizing email addresses on "gmail, yahoo, etc., routing accounts through numerous locations around the world, and utilizing pay-per-hour Internet cyber cafes.

These scams are outright theft and fraud and are a grave misrepresentation of the U.S. Army and the tremendous amount of support programs and mechanisms that exist for Soldiers today, especially those serving overseas.

In view of recent terrorist activities we are taking the forgery of this military ID very serious and using all our resources we will trace the perpetrator of this crime as we see this as an attack on The US.

I have enlisted the help of The FBI and passed all your evidence to them. They have vastly superior means to investigate this and then we will go and get them. I have also asked Detective Inspector John Morse from The Special Branch in The UK to contact you and liaise with you.

Below is the information Agent Rubble sent and am sending you what they found when they got the fake ID back from the lab.

The file has been received and is being processed as a matter of urgency as you requested. To update you so far:-

1) Enhanced photo (see attachment)

2) The phone number has been traced to Copperopolis, CA. - Still awaiting phone providers to furnish further details and phone logs.

3) Awaiting email service provider (Google) to come back to us regarding server routing of messages and logs. Initial reports are that they are confident of a hit.

We have also been doing background checks and processing data thru the NRTSU computer.

Of course all the things that I said about The FBI, INSCOM and Greater Manchester Police are a load of crap and I'm not a policeman. The address and telephone number I gave is a real one for The A Division in Manchester. It would be great if he called them asking for Sergeant Lou Nattic.

The numbers for the FBI and INSCOM are genuine too. But I doubt very much that he will call them asking to speak to Hugh Jorgen or Barney Rubble... Be nice if he did though.

I never got a reply from him again.
