But after I started this scambait, I started to get really interested in why he wanted just the check. Obviously it was to use against other victims, but I was curious to see how he would proceed so I played along.

Here is my doctored check. I sent this to him minus the MACSBaitStore.com writing on it. I didn't want this idiot using this check against someone else so I shrunk it down to about 2 inches wide by 1 inch tall. If he tries to enlarge it, it will become pixilated and blurry. He never contacted back after my last email so he was either happy with the check or knew he was being fucked with.
