This was the end of the bait - I wonder if he understood my reference in the last email. Unlike the previous "dying philanthropist" scambait, I tried emailing Mary from a different persona but her email was shut down. In the original scambait, after the initial character "died", I was continuing with the lawyer when my "friend" - who was one of my personas - contacted the dead character and received email responses (same letters, etc.). I informed the lawyer that Rose Fowler was alive that my friend was speaking to her. He, of course, told me it was an imposter, but I explained that she was sending the exact same emails to my friend, word for word, and they had the same misspellings and poor grammar. Then I lost him...
