Are you confused to what your name is? You introduce yourself as Garrick Oxford, you write from an email account that says "Isa Rasheed", and then you sign it "Yours Sincerely, Mr. Isa Rasheed". If you are confused to what you name really is, reach into your pocket, take out your driver's license, and copy the name from that - that should be the correct name. On another note, this is a small world after all, because I work for FedEx Supply Chain and Logistics in Hudson, Ohio. As a fellow employee, you probably already know that we get a discount on shipping charges (up to \$1,000.00 per year), and I also have an account with FedEx, so the package can just be shipped on my account.

My employee ID is OH44221-12558 and my full name is Gregory Wilson. You can send the package from your location using my account details. Thank you very much,
