This progresses and we meet the closer, SUCCESS WINNERS LAW FIRM, who I have dealt with before (Success At Last!).

Calvary greetings to you in the name of Our Lord Jesus Christ the giver of LIFE, I was really, glad and was deeply moved to know that you are such a person of faith and great love for humanity, with your passion for charity and devotion to God, I felt that there is much to life after reading your kindly e-mail, with all the prayers said for me and your great heart to help the needy with this inheritance by setting up CHARITY TRUST is a very good ideal, I must tell you that I am very happy to know that you will continue praying for me and my health until these trust funds gets into your possession to administer the TRUST for the good of humanity.

Thank you so very much for your urgent and favourable response to come forward to help and assist the poor people in our society, as a Christain it is the best thing to do; living a life of good will like our Lord Jesus Christ who is our perfect example is the best thing to do. Yeah, a good job where they use a FREE Gmail email account.

Did you look at the website?

No, it is a virus?

No, it is not a virus – it is my scambaiting website where I already have a scambait documented from YOU!

Yes, the same name, same email address, same “modality” – everything.

I've scambaited you before, you moron. It is on my website!

thank you but I don't need the web site. go away

Of course you don't – because you don't want to see that you have been made a fool of!

You are a freaking idiot! Do you know how many of these scams I see a week???

Go to hell

What I know about 419 Scammers...
