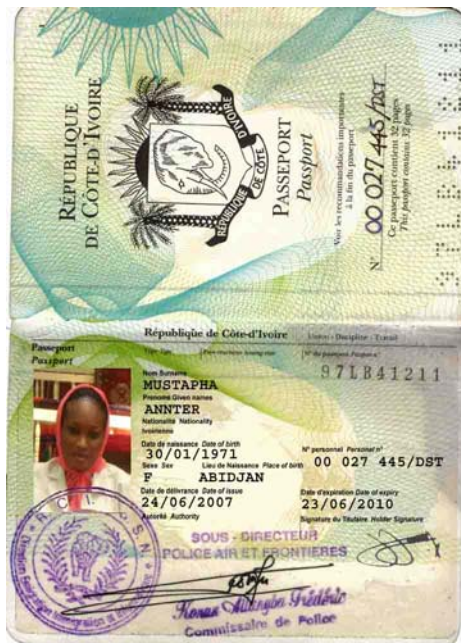
Dear Mr. Greg
